**CORRIGENDUM**

Guidelines for providing House Service Connections through 24X7 continuous pressurized water supply under KUWSMP in Hubballi-Dharwad, Belagavi and Kalaburgi Cities was issued vide Circular No: UDD 119 PRJ 2022, dated: 26.08.2022. In the said Circular SL I (C) (iv) read as "This full cost is to be collected upfront from the customer at a time" is substituted has given bellow:

*"The full cost is to be collected in monthly installment of Rs.50/- in the monthly water bill of the customer starting 6 months after the commencement of the Continuous Pressurized Water Supply till complete recovery or if the customer agrees to pay the full cost upfront then a rebate of 10% on connection Cost".*
